

Rules for use of digital copies of documents from the “Chaïm Perelman” (BE ULB 89PP) and “Fela and Chaïm Perelman” (USHMM) archival fonds

The use of digital copies of documents from the “Chaïm Perelman” (BE ULB 89PP) and “Fela and Chaïm Perelman (United States Holocaust Memorial Museum (USHMM) archival fonds, hereinafter referred to as “digital copies”, made available by the “Perelman Archives” research project team (dir. Prof E. Danblon), in collaboration with the Archives & Libraries of the Université libre de Bruxelles, hereinafter A&L, implies a certain number of codes of good practice which are laid out here. Their respect conditions access to documents in the digital archives. They are organised in accordance with the three axes: protection, use and reproduction.

Protection

1. Copyright

Neither the “Chaïm Perelman” archival fonds of the ULB nor the “Fela and Chaim Perelman” fonds of the USHMM were subject to any restricted access when they were entrusted to the institutions concerned.

2. Responsibility

In spite of the efforts made to guarantee the best quality and accessibility of the digital copies, there may still be some defects – such as, but not restricted to, incompleteness, errors in the files, a defect preventing access to the document, etc. The “Perelman Archives” research project team, alongside the A&L decline all responsibility as regards damages, costs and expenditures, including legal fees, entailed by the access to and/or the use of digital copies. Moreover, neither the “Perelman Archives” research project team nor the A&L can be called into question in relation to the subsequent use of the digital copies; and the designation ‘Archives & Libraries of the ULB’ and of the ULB, can be neither used nor tarnished, under the pretext of using digital copies made available by them.

3. Localisation

The digital copies are available via the interface of the Pallas database dedicated to the “Perelman Archives”, through authentication by login and password, and also accordance with these rules of use.

Use

4. Free

The “Perelman Archives” research project team and the A&L make digital copies of documents digitised by them available to the authorized public free of charge: no remuneration can be claimed by third parties either for their consultation or under the pretext of copyright.

5. Aims pursued

The digital copies may only be used for research or educational purposes or for private use. Any of these uses remains nonetheless subject to the authorisation of the “Perelman Archives” project team and the Archives & Libraries of the ULB. The downloading, copy and storage of the digital copies, as well as the exact facsimiles, prints, photocopies, copied / pasted (when the document is in text format), also require prior authorization. When making a request the user should mention the author, title and publisher of the document(s) concerned.

6. Quote

For all of these authorised uses, the user agrees to quote in his work, the documents used, with the words "Université Libre de Bruxelles – Archives & Libraries" accompanied by the essential details enabling the identification of the documents (author, title, date and place of publication).

7. Links

The creation of a link to a digital copy is not authorised.

Reproduction**8. In electronic format**

Without prejudice to the authorization provided for in Article 5 the downloading, copy and storage of the digital copies are permitted subject to prior authorisation; with the exception of depositing them in another *database*, which is forbidden.

9. On paper

Without prejudice to the authorization provided for in Article 5, prints and photocopies, in addition to copy/paste (when the document is in text format) are permitted subject to prior authorisation.

10. References

Whatever the medium of the reproduction, the removal of references to the ULB and to the Archives & Libraries of the ULB or to the collections of the USHMM in the digital copies is forbidden.
